

## Dog Training Liability Release and Waiver

I hereby acknowledge that I have voluntarily applied to participate in dog training activities with **Mutts To Order LLC** (“MTO”).

I am aware that there are inherent risks and hazards involved in activities with and around dogs, and I am voluntarily participating in these activities with knowledge of potential dangers. I am aware that any dog, regardless of training, handling, or environmental circumstance, is capable of biting and I expressly acknowledge the risks therein.

In order to participate in dog training classes or other activities, I (and, if a minor, my undersigned guardian), being fully informed of such risks and hazards, agree to assume all risks of such occurrences, and do hereby freely and voluntarily execute this Release and Waiver.

I (and, if a minor, my undersigned guardian) hereby release and forever discharge and hold harmless MTO and its affiliates, employees, agents, successors and assigns (collectively with MTO, the “MTO Parties”) from (and waive any claims or actions relating to) any and all liability, claims, demands and actions of whatever kind of nature, that I or my guardians or representatives have or may have that arise or may hereafter arise from my participation in any MTO dog training activities or related activities, including without limitation from any and all personal injury to myself, my dog, children in my charge, or harm to property or person caused directly or indirectly, through action or inaction of self or others, by acts that might occur in dog training classes, any other format of dog training activities or secondary dog training without trainer present or engaged.

Furthermore, without limiting the extent of the foregoing, I (and, if a minor, my undersigned guardian) do hereby release and forever discharge the MTO Parties from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my participation in the MTO dog training activities.

I understand that this Release and Waiver discharges the MTO Parties from any liability or claim that I may have against the MTO Parties with respect of any bodily injury, personal injury, illness, death, or property damage or other liability that may result from my participation in MTO’s dog training activities.

I agree to indemnify **MTO** and the other MTO Parties from any and all claims by myself, member of my family, or any agent while within training facilities, within my home or property, or in the general public as a result of any action of inaction, of either my dog or any other.

I (and, if a minor, my undersigned guardian) also agree to assume sole responsibility for injury or damage caused by myself, children in my charge, or by the dog I own or handle and further agree to indemnify, defend, and hold the MTO Parties and any instructors, trainers, assistants and property harmless from any damage, loss, liability, and expense, including legal costs and attorney’s fees, which result from damage caused by myself, children in my charge, or by the dog I own or handle.

I (and, if a minor, my undersigned guardian) expressly agree that the Release and Waiver is intended to be as broad and inclusive as permitted by the laws of the State of New Jersey, and that this Release shall be governed by and interpreted in accordance with the laws of this state. I (and, if a minor, my undersigned guardian) agree that in the event that any clause or provision of this Release and Waiver shall be held to be invalid by any court or competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release and Waiver which shall continue to be enforceable.

I am at least 18 years old, and I have read the policies for dog training and I agree to adhere to them.
